# 1.0 VISIT OF SRI JAIRAM RAMESH, HON'BLE MINISTER FOR RURAL DEVELOPMENT TO RUDSETI, UJIRE

Sri Jairam Ramesh, Hon'ble Union Minister for Rural Development paid a visit to Dharmasthala on the occasion of 30<sup>th</sup>



Anniversary of Sri K s h e t h r a Dharmasthala Rural D e v e l o p m e n t Project, a unique project promoted by Dr.D.Veerendra Heggade, for the empowerment of rural women by organizing Self-help

Groups. Sri Jairam Ramesh was accompanied by Sri K. N. Janardhana, Chief Project Co-ordinator, Monitoring Cell for RSETIs, Bangalore.

On the occasion of his visit to Dharmasthala, Sri Jairam Ramesh visited Central Secretariat, RUDSETI, Ujire and spent quality time in enquiring about the functioning of the Central Secretariat. He took keen interest in understanding the unique concepts of RUDSETI and appreciated the initiatives of RUDSETI in addressing the unemployment problem of the country.

The Hon'ble Minister later visited the RUDSET Institute, Ujire too and interacted with the trainees undergoing training in Computer DTP, Agriculture and Mobile Repairing & Servicing batches. Prof. S.Prabhakar, Secretary, SDME Trust and Dr. LH Manjunath,



Executive Director, SKDRDP also graced the occasion.



Later in the day, addressing a Press Conference Sri Jairam Ramesh lauded the initiatives of Dr. D. Veerendra Heggade in addressing the unemployment problem of the

country by starting Rural Development & Self Employment Training Institute way back in 1982. The very fact that RUDSETI has been able to provide self employment opportunities to more than 70% of the trained youth in various RUDSET Institutes attracted the attention of the Government of India and thus MoRD advised all the Banks with Lead Bank responsibilities to open RSETIs in their Lead Districts, he said. He expressed concern that out of 620 Lead Districts in the country, though 526 RSETIs are already functioning across India, they are yet to come up to the level of best performing RUDSETI and hence the Ministry thought it appropriate to enter into MOU with Dr. D. Veerendra Heggade for effectively running these numerous RSETIs. Sri Jairam Ramesh solicited co-operation from all the sponsoring Banks to achieve the set objectives of the Ministry in addressing the unemployment problem of the country.

#### 2.0 CONCLAVE OF RSETI DIRECTORS

As explained in the previous issues, on the advice of Dr. D. Veerendra Heggade, Hon. Chairman of National Advisory Council for RSETIs, MoRD gave directions to all the participating Banks to organize a 2 - day Conclave of RSETI Directors as an Annual event. Bank of Baroda, United Bank of India, Dena Bank, Punjab National Bank, Canara Bank, Central Bank of India, SyndicateBank, State Bank of Hyderabad, Union Bank of India and UCO Bank organized the Conclave for their RSETI Directors in the previous quarters. During this quarter. Allahabad Bank, Andhra Bank took the initiative in organizing a 2-day Conclave for their RSETI Directors. In addition to these Conclaves, the Banks who have sponsored less than 10 RSETIs took the initiative in organizing a 2 day Conclave for their RSETI Directors in two batches at NIRD, Hyderabad on May 1-2, 2012 and May 3-4, 2012. Furthermore, State Bank of Patiala, at the directions of MoRD took the initiative in organizing a Common Conclave of Directors of RSETIs sponsored by Associate Banks of State Bank of India at Info Tech Academy, State Bank of Patiala, Patiala.

During the first day of the Conclave, inputs on how to administer Micro Lab exercise to the trainees, sessions on topics like Motivation – why and how?, Identification of Training needs, Methods of generation of applications, selection of candidates for trainings, Methodology of organizing entrepreneurship awareness / motivation camps etc. were provided. Two successful entrepreneurs trained by one of the RSETIs of the sponsoring Banks were given opportunities to share their experiences and interact with the participants. In addition to the above, Smt. Renuka Kumar, Dy Secretary, MoRD, made a presentation on the expectations of the Ministry in taking the RSETI movement to newer heights. She also requested the Bank executives to provide all support to the RSETIs so that the Directors can play a pivotal role in addressing the unemployment problem of the country in a very meaningful way.

Besides the afore mentioned presentations, Sri K. N. Janardhana, Chief Project Co-ordinator presented a paper on 'Journey from RUDSETI to RSETI' and briefed the participants about MoRD guidelines in running the RSETIs successfully. During the presentation, he also highlighted the role of sponsoring Banks in providing requisite support to the RSETIs which will go a long way in meeting the objectives and philosophy of MoRD.

On the 2<sup>nd</sup> day of the Conclave, a thorough review of functioning of each RSETI was done by the officials from the Monitoring Cell for RSETIs in the presence of officials from MoRD and the Executives of the sponsoring Bank. During the review, the gaps in the functioning of the RSETIs were identified and remedial measures were suggested to improve its functioning. Furthermore, Sri O N Bansal, Project Director for RSETIs, NIRD, Hyderabad, discussed issues pertaining to allotment of land and progress of the construction of new campuses.

# 3.0 Success Stories

#### A RURAL BPO WITH A DIFFERENCE

#### A Success Story from INDSETI, Puducherry, Tamil Nadu

RSETIs throughout the length and breadth of the country are reaching the unemployed youth by offering varieties of training programmes to take up self employment ventures. While lakhs of youth have successfully taken up self employment activity on their

own with the intervention of various Banks, here is a rare example where six women came together to start a Rural BPO at Thavalakuppam, a small village in Puducherry District of



Tamil Nadu after undergoing a Computer DTP training programme organized by INDSETI, Puducherry sponsored by Indian Bank in association with Puducherry Multipurpose Social Service Society, a NGO who offered the infrastructure and faculty services.

All these women – G Karthiga, G Lakshmi, V Vinodhini, S Thamilselvi, V Rajeswari and N Rajakumari – hail from very poor family background with a minimum of 10<sup>th</sup> pass and they have one thing in common i.e., drive to take up some self employment activity

to support their families. A few of them got to know about RSETI through news papers and a few through the past trainees. When they applied for a Computer DTP training programme, little did they know that their lives were going to be changed after the training was over.

During the course of training, this group of six women who were earlier not known to each other evinced keen interest in learning all the inputs. What impressed them were the soft skills imparted during the training programme which enlightened them that entrepreneurship is not hereditary but anybody with an urge to take up self employment can become an entrepreneur. Other inputs like competencies required for a successful entrepreneur, effective communication and management skills, customer behavior etc. strengthened their desire to take up self employment. It so happened that during a group discussion all these women came together and discussed about starting an enterprise, but capital was a stumbling block. Even then the discussions continued and suddenly an idea sprang up - Why not start a group enterprise by investing a little amount of money from each member of the group. This idea gathered momentum, took a concrete shape and thus a Rural BPO was born in Thavalakuppam village.

The idea brought out by this group of six enterprising women impressed the RSETI Director and he took special interest in supporting the initiative. The Puducherry Multipurpose Social Service Society who were associated with the programme was also impressed by the enterprising quality of these young women and it offered to provide the infrastructure and a suitable place to start the rural BPO. Really a great gesture by the NGO!!!

Today these women are a happy lot. Free training and hand holding by IND RSETI Puducherry, free infrastructure by the NGO and of course the burning desire of these women to take up self employment has culminated into a successful group enterprise. Each one of them is earning Rs. 3,500/- to 4,000/- per month and they owe their success to IND RSETI in changing their lives.

#### AGE NO BAR FOR ENTREPRENEURSHIP

#### A Success story from SBI RSETI, Nanded, Maharastra

Sri Ram Rao Amrut Vachchhewar, a resident of Savana Village of Nanded District of Maharashtra belongs to a family with below

poverty status. After completing his higher secondary, though he was interested to study further, the poor condition of his family did not support his aspirations. As is the practice in rural areas, he was married at a very young age.



Ram Rao was working as a helper under an Electrical Contractor and was earning Rs. 2,000/- per month. This income was too meager to take care of his family. As the days passed, Ram Rao became father of two children and the poverty conditions worsened. He was always looking for an opportunity to do something which may earn some income so that he could take care of his family, but the age was a constraint because he was 31 years old by then. Ram Rao had decided

that no one will come to his rescue at this age. But the rays of hope began to shine when he happened to meet the Extension Officer of Panchayat Samithi, who told him about the training programmes offered by State Bank RSETI, Nanded to the aspiring youth to take up self employment.

Eager to know more about RSETI and its activities, Ram Rao personally went to RSETI and met the Director. He was surprised to know that various training progrmames are offered free of cost by the RSETI to take up self employment ventures in different fields. Sri Ram Rao chose to undergo training on "Domestic Electrical Appliances and Repairs" since he had experienced the shortage of electricians at his village.

After attending the 30 day training programme, Sri Rama Rao had a refreshing experience since he realized that even at the age of 31 years, there are opportunities to encash upon if one has the zeal and enthusiasm. The soft skills that were imparted during the training programme made him stronger to take up some self employment activity at the earliest possible opportunity.

Though Ram Rao was eager to start an Electrical business, funds were the main constraint. When he expressed his desire to start a small business of his own to his friends and relatives, they came forward to help in a small way. This helped Mr.Rao to mobilize a humble capital by which he opened a small shop "PRASAD ELCTRICALS & ELECTRONICS" at Himayatnagar, a taluka place 5 Kms from his village.

While the hard skills learnt during the training programme helped him to attend to the complaints by his customers the soft skills helped him to develop good relations with the customers and thus Sri Ram Rao is now able to earn Rs. 6,000/- to Rs. 8,000/- per month.

While sharing his experience as the owner of "Prasad Electricals & Electronics" Sri Rao says "I am proud of RSETI, Nanded, which has shown a direction to my life"

#### A TURNAROUND FOR REENA

#### A Success story from UCORSETI, Bilaspur, Himachal Pradesh

For Reena Devi till she was 32 years old, life was very easy going.

Married to MrSanjeev Kumar, a private Contractor at the age of 22 and with two children, the family was leading a happy life. But the fate had decided something else for Reena. Her husband suffered from Liver disease and after prolonged illness he passed away, leaving behind two small kids and a helpless Reena. Lakhs of rupees spent on the treatment of Sanjeev Kumar went in vain.



The only person to console Reena was her brother-in-law, but after some time he became busy with his own life and Reena was virtually left alone. With all the savings exhausted on the treatment of her husband, Reena looked for many avenues by which she can earn livelihood for herself and for the children. The immediate

avenue available was to serve as a domestic maid which helped her earn some income to meet the daily needs of the family.

One day, when she was sitting in a sad mood at home, her neighbor came with a newspaper cutting which spoke of free self employment training programmes offered by UCO RSETI, Bilaspur to the unemployed youth. Hoping that she may get some solution to her problems, Reena went to RSETI to enquire about the training programmes which may help for take up some self employment. On interviewing the candidate, the Director suggested her to undergo a 21 day "Dress Designing programme for women" because she had some experience of stitching. With lots of apprehension, Reena agreed to undergo the training.

On the due date she went to RSETI for the training where it was a new experience for Reena from day one. The Dress designing programme started with a different note. What she anticipated was pedaling a tailoring machine with a pair of scissors and some clothes to stitch for. But the first day of training broke her expectations. Instead of a faculty teaching the skills of designing dresses, the Director of RSETI started teaching the skills of life by giving inputs on motivation which made her accept the realities of life and to face the challenge ahead of her with grit and determination. The training generated lots of interest and Reena took keen interest in understanding all the inputs given in the training programme and on the day of valediction she decided to start a humble tailoring unit of her own. The sponsoring Bank of RSETI i.e. UCO Bank came to her assistance and gave a loan of Rs. 30,000/- by which she could purchase the machines and all the materials required for starting a tailoring unit. The quality of stitching produced by Reena attracted many customers and today she is able to earn Rs. 5,000/- per month after meeting all the expenses.

With a broad smile on her face Reena says "I am extremely thankful to UCO RSETI Bilaspur who have shown me the light in my life".

#### FROM STATIONERY SHOP TO MOBILE SHOP

#### A Success story from SyndRSETI, Kumta, Karnataka

Sri Vinayak Vasant Bhat a native of Honnavar, Karnataka belongs to a middle class family. Being fairly good in studies, he did his

graduation in Arts. After graduation, like any other youth Mr. Bhat also dreamt of getting a job somewhere by which he can earn his livelihood. Thus he sent in his application for a suitable j o b to many Organizations / Offices / Companies but he could not succeed. When all his efforts failed, he



opened a stationery shop and was earning about Rs.1500/- to Rs.2000/- per month which was not adequate to maintain the family. Desperate with the low income, he was always looking for opportunities to take up some other income generating activity to support his family financially.

One day while discussing with his friend about his interest in taking up some income generating activity, his friend suggested

about taking up a suitable training at SyndRSETI at Kumta where many programmes related to self-employment are being imparted. Out of curiosity Mr.Vinayak Bhat visited SyndRSETI, Kumta and made enquiries regarding the nature of training programmes organized by them. What impressed Mr. Bhat was varieties of training programmes offered by the RSETI and that too free of cost. Thus he wasted no time and applied for a training programme on 'Mobile Phone Servicing', which was found more suitable to him.

After selection procedure, he came to SyndRSETI for training which gave him good practical exposure on different aspects of Mobile Phone repair for 30 days and he could see his dreams of becoming a successful entrepreneur being realized.

Being already in the business of stationery items, though in a small scale, Mr. Bhat had some exposure to dealing with customers. But the soft skills imparted by RSETI along with the technical skills viz., inputs on entrepreneurial competencies, goal setting, systematic planning, self confidence, marketing, project report preparation etc. came as a boon to Mr. Bhat.

Finding a suitable place to start a mobile repair unit on completing the training was not a constraint since there was some space available in the existing Stationery shop itself. But capital to purchase the tools for mobile repairing was a constraint. At this point of time, he again approached SyndRSETI who came to his assistance by getting him financial assistance of Rs. 1.00 lakh from Syndicate Bank, Honnavar.

Today Mr. Vinayak Vasant Bhat is a happy young man. Now his main activity is mobile servicing and he is also continuing his business on stationery goods as well. His unit VARSH TRADERS is a popular shop in Honnavar giving quality service to the customers and Mr. Bhat has recently taken dealership in MTS mobile. From an earning of Rs. 2,000/- per month in his Stationery shop today Mr. Bhat is earning about Rs. 10,000/- per month. In addition, he has given employment to one person. **Kudos to SyndRSETI, Kumta and also SyndicateBank, Honnavar** for bringing in change in the life of Mr.Vinayak Vasant Bhat.

"I was always chasing wage employment, but SyndRSETI, Kumta has enlightened me about the opportunities in self employment. I am deeply indebted to SyndRSETI, Kumta" says Mr.Vinayak Bhat with pride.
