Second round of Review Meet of State Project Co-ordinators



The second round of Review Meet of the State Project Co-ordinators was held on 3.8.2013 at RUDSETI, Ghaziabad. Newly appointed SPCs also took part in the review meet and it provided them a platform to

appreciate and understand the practical experiences of the senior SPCs.

During the Review Meet, CPC explained in detail the rationale behind the initiatives of MoRD in grading all the RSETIs under two categories. He further explained the expectations of MoRD in taking the RSETI movement forward and made a thorough review of the performance of each SPC and gave suggestions to bring in further improvements in the functioning of the RSETIs. All the SPCs were advised by the CPC to leave no stone unturned in addressing the gaps in the functioning of each RSETI in their command area and ensure that all the RSETIs are brought on par with the best performing RUDSETI in the country.

During the Review Meet, all the senior SPCs were provided an opportunity to share their experiences which was indeed a very good learning experience for all the new SPCs.

SECOND ROUND OF CONCLAVE OF RSETI DIRECTORS

In terms of the MoRD guidelines, the Conclave of RSETI Directors should be organized by the sponsoring Banks as an **annual event**. This is to ensure that all the gaps identified in the functioning of the RSETIs during the Conclave are addressed so that they perform on an equal footing with the best-performing RUDSETI in the country. While the first round of the Conclave focused on capacity building of the RSETI Directors and review of the RSETIs, the second and subsequent rounds of the Conclave will focus exclusively on a thorough review of the performance of each RSETI by Chief Project Co-ordinator from the Monitoring Cell for RSETIs, wherein the gaps in the functioning of the individual RSETIs will be identified and suggestions will be provided to bridge the gaps.

In compliance with the MoRD guidelines to organize a 2-day

Conclave of their RSETI Directors as an annual event, **Bank of Baroda, Canara Bank, Dena Bank, Punjab National Bank, Andhra Bank, Indian Bank, Indian Overseas Bank, State Bank of Hyderabad, SyndicateBank, UCO Bank, Associate Banks of State Bank of India, United Bank of India, Allahabad Bank, Central Bank of India (apart from a Common Conclave of Banks which have sponsored less than 10 RSETIs)** organised the Conclave for their RSETI Directors in the previous quarters. During this quarter, **Union Bank of India and Jammu & Kashmir Bank** took the initiative in organizing Conclave for their RSETI Directors and a summary of the Conclaves arranged by the above Banks during the reporting quarter is as follows:

Conclave of RSETI Directors of Union Bank of India

A two day conclave of Directors of RSETIs sponsored by Union Bank of India was organized at Varanasi on 22nd and 23rd August 2013. The conclave was inaugurated by Sri V S Dole, General

FRUITS OF STRUGGLE

A Success story from JSS RUDSETI, Mariyala, Karnataka (jointly sponsored by JSS Mahavidyapeetha and State Bank of Mysore)



Mr Mohamad Yunus is the last son in the family of four children of Mr Chote Sab who works as a laborer in a small Tinkering shop in

Mariyala in Chamrajnagar District of Karnataka State. Owing to meager income of Chote Sab, he could not afford giving a decent education to his children. Though Mohd. Yunus was eager to continue his studies, he could not continue after 10th Standard since his father was not in a position to meet the expenses of his education.

Deprived of further education, Mohd. Yunus was just passing time without doing any work. One of his friends suggested Yunus to undergo a training in an Electrical shop known to him at Mysore. Accordingly Mohd. Yunus joined as a labour in the electrical shop. Without aspiring for any salary, Mohd. Yunus took the opportunity to learn various skills related to electrical works and after working in the shop for more than three years when the owner did not agree to pay him any salary, Mr Yunus joined another electrical shop in Mysore where he started earning Rs. 100/- per day plus his travel expenses from his native place to Mysore daily.

After gaining sufficient experience in electrical works, Mohd. Yunus looked for opportunities where he can earn more. At this point of time, he came across a news item in a local news paper calling for applications from the interested candidates to join a training programme on "AC, Refrigerator & Water cooler repairs" offered by JSS RUDSETI, Mariyala. Mr Yunus thought it to be a very good opportunity to upgrade his skills and thus he approached the Director of the Institute. On interviewing Mr Yunus, the RSETI Director selected him for the training. Mr Yunus was very happy to learn that the training offered at the Institute was free of cost that too with free boarding and lodging.

Having already acquired some skills in electrical works, it was very interesting for Mohd. Yunus to learn during the training programme how his skills can be made use of in servicing of AC and Refrigerators. This apart, the soft skills like entrepreneurial competencies, marketing, customer management etc. imparted during the training not only boosted his confidence but also helped him to understand how these skills can be transformed into business skills.

Thus Mohd. Yunus immediately after successful completion of the training established his own AC & Refrigerator servicing unit in Nanjangud by investing Rs. 70,000/- which he borrowed from his friends and relatives. All that he learnt right from the day he joined as a labour in an electrical shop till he completed training at JSS RUDSETI, Mariyala helped Mr Yunus to successfully run the business. Today Mohd. Yunus is a proud owner of his business earning a monthly income of around Rs. 15,000/-. Recollecting his days when he struggled to learn the skills without any salary, Mr Yunus says, "JSS RUDSETI has shown me the way to success and I am deeply indebted to the Institute".

ONE ENTREPRENEUR - THREE SOURCES OF INCOME

A Success Story from PSB RSETI, Moga, Punjab sponsored by Punjab and Sind Bank



Here is the story of an agricultural labour turned entrepreneur in a backward village of Moga District in Punjab.

Mr Rajinder Singh is the last among the three sons of Mr Lal Singh, a marginal farmer from a small village Himmantpura in Moga District of Punjab. The monthly income of the Lal Singh was hardly Rs. 3,000/- which was not sufficient to take care of the daily needs of his family leave alone giving education to the children. The two acres of land available with him was not suitable for cultivation and hence his children too started working as agricultural labours.

On one fine day RSETI, Moga organized an Awareness camp in Himmantpura village where the Director explained about the activities of the Institute and the various training programmes offered free of cost to the unemployed youth in the District. Mr Singh attended the camp and soon after the awareness camp, Rajinder Singh personally discussed with the Director as to whether he being only a 8th pass can join the training programme. The Director encouraged Mr Rajinder Singh to join for a 10-day programme on Dairy & Vermicompost which will be of more use to him.

For Mr Rajinder Singh, it was indeed a boon that he was selected for a training programme at the RSETI. With all sincerity, he attended the training programme and learnt in detail modern techniques of dairy farming, maintenance of cow shed and the inputs on how to increase the milk production etc which really motivated Mr Rajinder Singh to take up this activity. At this juncture, requisite capital to purchase the animals was a problem for Mr Rajinder Singh but soon he was elated when his problems were addressed by the

Director during sessions on Banking where the Director informed on the various schemes in the Banks which help the unemployed youth to take up self employment. Other learning experiences during the training like marketing, communication skills, problem solving skills etc. boosted the confidence of Mr Rajinder Singh to take up Dairy activity immediately after the completion of training programme successfully.

Looking at the enthusiasm of Mr Rajinder Singh, the RSETI Director helped him to secure a loan of Rs. 1.00 lakh through Punjab & Sindh Bank of Himmatpura Village by which he purchased four cattle and erected a small shed in his farm. He made use of all the skills learnt during the training programme in his activity. He started collecting milk from neighboring villages and including the milk of his own farm, he could sell the milk for a good margin in the nearby city. With a cool profit of around Rs. 6,000/- per month, he made sure that the bank loan installments are repaid in time.

As the days passed, an idea flashed across Mr Rajinder Singh to give a new looks to his activity by producing bye products of milk. When he expressed this idea to the RSETI Director, he supported the same. Branch Manager of Punjab & Sind Bank sanctioned a further loan of Rs. 1.00 lakh to Mr. Singh to pursue this additional activity.

Today Mr Rajinder Singh is the proud owner of a Milk Parlour in Himmatpura village where he sells Curds, Cheese and other milk by - products. After regularly repaying the loan installment, Mr Rajinder Singh is earning a net profit of Rs. 10,000/- per month from this activity.

After tasting success in both the activities, one more idea came to his mind. His father had 2 acres of land which was not put to use as it was not suitable for cultivation. During the training at RSETI, inputs on vermi compost motivated him to go in for few Vermicompost pits in his lands. He also sells the Vermicompost in small pockets which costs Rs. 10/- each and by sale of vermin compost, he earns a net profit of Rs. 3,000/- per month.

From all the three activities, Mr Singh is making a total profit of Rs.19,000/- to Rs.20,000/- per month and is leading a happy life. By taking up above activities, truly Mr Rajinder Singh is an inspiration to other unemployed youth.

LIGHT UP YOUR LIFE AND OTHERS TOO

A success story from IOB RSETI, Thanjavur, Tamil Nadu sponsored by Indian Overseas Bank



Sri.R.Kumararajan hails from a remote village Verapudaiyanpatti in Thanjavur District of Tamil Nadu. His father Sri Rengasamy being a landless agricultural labour could hardly afford the education of his son but Kumararajan was bent upon pursuing higher studies. Looking at the enthusiasm of his son, Rengasamy with great difficulty gave education up to Diploma in Electrical Engineering to his son. Mr Kumararajan realized that his father cannot afford his further studies and hence started looking for a salaried job so that he can earn his livelihood. But all his efforts to get a suitable job were in vain and ultimately he joined as a helper with an electrical contractor as daily wage earner.

In the course of time, Kumararajan happened to attend an Awareness Camp organized by IOB RSETI, Thanjavur at Budalur village. It was a pleasant surprise for Kumararajan to learn during the awareness camp that IOB RSETI at Thanjavur is offering free training programmes to the unemployed youth under various trades which included courses on electrical related activities as well. Though he was technically qualified, he was not having any knowledge as to how he can start a business of his own and he requested the RSETI Director to give him an opportunity to undergo training in Electrical Wiring and Rewinding course. The RSETI Director encouraged him to join the course.

The 30-day Electrical wiring and rewinding course at IOB-RSETI Thanjavur was indeed a god sent opportunity for Mr Kumararajan, since the inputs he received during the training programme were useful in shaping his life as an

entrepreneur. During the training period, besides the technical skill and practical experience, Kumararajan benefited immensely by the soft skills such as Entrepreneurial competencies, Marketing & Customer management, Business Management, Financial aspects etc. At the end of the programme, Mr Kumararajan was a highly motivated individual to start his own self Employment venture.

Without wasting much time after the training, Kumararajan used his business skills and got an order for the electrical wiring works in a small workshop which he did successfully with two of his co-trainees. This helped him gain confidence in taking up bigger job orders and with continuous efforts, he got the opportunity to take up wiring at an industrial unit in a big way. The quality of the work done at industrial unit was well received by his customers which led him to secure more and more orders in house wiring. As days passed, Kumararajan put up an assembling unit for producing electrical panels where he has given employment to 10 persons. This indeed is a great achievement in the life of Kumararajan. As an electrician, he has not only found light in his life but has also given light to 10 others. With the increase in turn over, Kumararajan is able to earn a monthly income of Rs.60,000/- and today he is an 'A' class Electrical Contractor for Southern Railway in Trichy. **Really a proud moment to Mr Kumararajan.**

Mr Kumararajan, despite growth in his business and earning sufficient income every month remains the same humble person and visits the RSETI regularly to share his success with the trainees and motivates them to become entrepreneurs like him. The RSETI Director considers him as an 'Ambassador' for IOB RSETI, Thanjavur.

The urge in Kumararajan to pursue his studies never faded. Alongside his business, he completed his **Bachelor of Engineering** in correspondence course and is leading a very happy life.
